Dear Senator

On 17 and 18 September 2024, the Senate agreed on General Business Notice of Motion No.622 and 624 respectively, relating to the provision of international student data for higher education providers, and correspondence with universities on international education. The motions were moved by Senator the Hon Sarah Henderson.

In response to these orders, I request you table the data enclosed together with copies of letters sent to each public university regarding the Education Services for Overseas Students Amendment (Quality and Integrity) Bill 2024 and Ministerial Direction 107.

Notice of Motion No. 622

The data in response to question 1 (c), (d) and (e) relates to higher education students only and are sourced from the Tertiary Collection of Student Information (TCSI). In some cases the providers listed will also have VET students but these are not included in the data supplied and the data is the responsibility of the Department of Employment and Workplace Relations.

For all higher education providers, the response to question 1 (c), (d) and (e) includes:

- The number of onshore international students (headcount) for 2019, 2022 and 2023
- The total number of onshore students (domestic + onshore international) for 2019, 2022 and 2023, and
- Onshore international students as a proportion of total onshore students for the 2019, 2022 and 2023.

Cell counts less than 5 have been suppressed as per standard practice.

Verified 2024 higher education student data from TCSI will not be available before mid-2025 and is therefore not included.

The data requested by the Senate raise valid considerations regarding commercially sensitive information. In order to respond appropriately to the terms of the Senate motions, the data is provided in full irrespective of these considerations.

Thank you for your correspondence of 27 March 2024 regarding the Australian Government's Migration Strategy and its impacts on international student visa processing. I wanted to write to you following the announcement of the Draft International Education and Skills Strategic Framework (Draft Framework).

Reforms under the Migration Strategy include making the visa system simpler and more efficient, replacing the Genuine Temporary Entrant requirement with a Genuine Student requirement and introducing higher English language requirements for international students and graduates for all universities. I appreciate your concerns about student visa processing reforms that focus on quality and integrity and the impact on the financial situation of universities. I note the challenges that Ministerial Direction 107 has posed to Flinders University's international student cohort, particularly to students of the twinning collaboration with the Rajagiri School of Engineering and Technology.

While the student visa program and the processing of student visas are a matter for the Hon Clare O'Neil MP, Minister for Home Affairs, the Department of Education is closely monitoring the impact on universities.
